Who We Serve

NPH USA supports Nuestros Pequeños Hermanos (NPH, Spanish for "Our Little Brothers and Sisters"), which is currently raising more than 3,400 boys and girls. An additional 2,300 students who live outside the homes receive scholarships, meals and health care. In 2015, more than 99,000 services were provided to children and adults through community outreach programs.

Dear Supporters,

NPH USA is the United States fundraising arm of Nuestros Pequeños Hermanos (NPH). Your generous support of our organization is changing the lives of approximately 3,400 severely disadvantaged children living in NPH homes in nine countries of Latin America and the Caribbean. Many thousands more are helped through NPH medical facilities and other outreach programs. The children, or pequeños, are not available for adoption. Instead, each of the NPH homes constitutes a supportive family where the pequeños are given unconditional love, care, and education and are taught a sense of responsibility just as you would do for your own children. Many of them have gone on to become engineers, doctors and other professionals. All are given the skills they need to provide for and raise healthy families of their own.

At NPH USA this past year:

- General funds sent to NPH have increased by more than 10%,
- We have committed to send even more funds in 2016,
- A strategic plan designed to raise an ever increasing amount for NPH has been adopted,

- Many new donors and child sponsors have joined, and
- New members with a passion for the mission have joined the board.

This bodes well for a future in which we can provide significantly more support for NPH and break the cycle of poverty for an increasing number of children. Details of the above will be found elsewhere in this report.

The end of 2015 marks the completion of my term as Chairman of the board. It has been a tremendous privilege to work with our CEO, other board members, the dedicated staff and our donor community in furthering the work of NPH. Nestor Jaramillo will now assume the chairmanship and I am confident he will enjoy your support in carrying on, and expanding, the work of this organization.

Please accept my sincere gratitude on behalf of the pequeños for your support.

2015 Treasurer's Report

Due to the amazing generosity of our donors, NPH USA has once again recorded another successful year and provided almost \$11 million in cash and medical supplies to NPH International. During the previous five years, your donations to NPH USA have increased an average of 14% per year – resulting in \$3.5 million more of annual support to NPH International and the children that they serve. The organization continually generates a healthy program ratio and 2015 was no different as our 75% puts us in excellent standing with the major U.S. fundraising rating agencies.


During 2015, NPH USA provided \$10.9 million of support to NPH International, comprised of \$9.2 million of cash and \$1.7 million of materials (primarily medical in nature). In 2015, we achieved an operating surplus of \$0.5 million, even after increasing our support to NPHI from the preceding year. This surplus stemmed primarily from our growth in unrestricted revenue and helped to drive an increase in our cash reserve to \$3.3 million. In light of our strong record of growth and healthy cash position, NPH USA's board committed to increase the level of support that it provides to NPHI in 2016 by \$750,000. Once again, this could not be accomplished without the amazing dedication of you, our donors.

NPH USA is committed to maintaining a healthy financial position and balance sheet. We continue to closely monitor our financial performance and with the help of the NPH USA Board and Finance Committee will take actions to ensure that we will always be there for the children of NPH. As our staff implements fundraising plans, your continued support remains the absolutely vital key to our success. We hope, and believe, that you will continue to keep the children of NPH uppermost in your hearts and minds.





Community Outreach

All of the NPH homes assist people in their communities in a variety of ways. The homes with their own schools offer scholarships to local children and those with clinics provide health care services to thousands of children and adults each year. Other programs include offering vocational education to unemployed adults in the Dominican Republic and providing child daycare to working mothers in Honduras. In addition, the homes provide disaster relief when needed.

- **Bolivia:** Initiated a dairy cows project and a fish production project
- **Dominican Republic:** Completed construction of three vocational workshops
- El Salvador: 21 high school graduates began their year of service
- **Guatemala:** Launched a bakery to help local fundraising and integrated a learning store
- Haiti: Constructed two new kitchen facilities and re-structured childcare programs for greater efficiency
- **Honduras:** Added a gravityfed rainwater system for irrigation
- Mexico: Installed a second greenhouse and expanded community outreach
- Nicaragua: Constructed tilapia tanks and received government accreditation of vocational workshops
- **Peru:** Completed the eighth house and had the first harvest of green beans

The Seattle Institute began in Fall 2011 in order to continue Father Wasson's legacy by developing a future generation of leaders for our NPH homes. The curriculum is based on principles of servant leadership and grounded in our NPH philosophy. The small size of the program offers the capacity to engage in challenging and rigorous personal and group work, as well as the ability to adapt to the needs of each student.

Each participant lives with a host family, works with an intergenerational mentor, participates in job-shadowing experiences, and studies intense English at a local community college. Additionally, the students participate in weekly leadership courses, weekend workshops, service activities, and several longer retreats during the year. They are coached in their personal growth by the program director and others who support the program in Seattle.

The NPH USA International Volunteer Program sends qualified individuals, married couples and families to support the staff and children living at the NPH homes. Volunteers commit to at least one year of service, live on-site and hold a full time job. They are provided with room and board, health insurance, access to basic medical care, and a modest stipend, but pay for their own travel expenses.

There is a critical shortage of pediatricians in Haiti. To address this gap, the Pediatric Residency Program was developed in 2013 as part of the St. Damien Collaborative for the Improvement of Pediatrics. The program is supported by a network of committed children's hospitals in the U.S.

Fr. Wasson Legacy Endowment, Inc. (FWLEI, Federal Tax ID #91-2005679) is a nonprofit, nonsectarian 501(c)(3) organization incorporated in Delaware in 1995. The purpose and mission of FWLEI is to create a substantial and growing financial corpus (the Endowment) that will generate income and help provide long-term financial stability for Nuestros Pequeños Hermanos.

Directors are nominated by NPH USA and elected to represent geographic areas paralleling the regions of the NPH USA offices. The Executive Director of NPH International and CEO of NPH USA are ex-officio voting members of the Board of Directors. The NPH USA offices and NPH Mexico raise funds for the Endowment. Donors receive receipts from NPH USA, which may be used to obtain deductions from U.S. taxes as provided by law. FWLEI may make an annual distribution from earnings to NPH USA for support of the NPH homes.

President's Report

The Father Wasson Legacy Endowment, Inc. (FWLEI or the Endowment), established in 1995, provides a repository of long-term financial assets and an on-going source of financial support through NPH USA to Nuestros Pequeños Hermanos (NPH). FWLEI is a separate 501(c)(3) charitable organization.

The Endowment net asset balance showed a slight decrease, to a total of \$13.4 million at yearend 2015 from \$13.7 million at yearend 2014. This occurred primarily due to flat financial performance in 2014, even while FWLEI made a \$576,000 distribution to NPH USA. During the five years 2010 through 2015, FWLEI has distributed almost \$3 million to benefit the children of the NPH family. (In January 2016, the FWLEI board authorized another distribution of \$659,000.)

Following the January 2016 Board meeting, my second threeyear term on the FWLEI Board has concluded. The By-Laws do not allow a third consecutive term. I thank the Endowment Board for the opportunity to serve. The Board will proceed under the trusted and tested leadership of Charlie Swope – President, Earl Frye – Vice President, Jean Gray – Treasurer, Claire Topp – Secretary, and Dave Seidel – Investment Committee Chair, as affirmed at the January 2016 Board meeting.

The primary role that FWLEI plays in the NPH USA fundraising platform is to offer a directed instrument– one with a strong record of oversight and investment performance – for appropriate planned gifts and estate opportunities. Please note the on-going efforts to build support for FWLEI through the staff and supporters of NPH USA. A complete fundraising operation offers an endowment opportunity for donors to contribute to the longer-term sustenance of the beneficiary organization. FWLEI plays that role for U.S. donors to NPH. If you are interested in learning more or know of someone who should hear about this opportunity, we urge you to call your NPH USA Regional Director or one of our board members. 2015 Portfolio Management Report

The Father Wasson Legacy Endowment portfolio is managed at Morgan Stanley by the Ziminsky Group. At yearend 2015, total assets equaled \$13.38M. Vic Ziminsky has provided excellent investment results for the Endowment Fund, outperforming the benchmark in eight of the past nine years.

The Endowment Fund investment portfolio – 2015 yearend balance \$13.26 million achieved a 1.47% gross return (approximately 0.62% net of fees) during 2015, exceeding the 0.08% performance benchmark for a portfolio containing 65% world equities and 35% fixed income. "Stealth bear market' was how some equity analysts chose to broadly describe how equities performed in 2015," was the phrase used in Vic's yearend commentary. 2015 returns were not robust, but FWLEI achieved a positive return in a challenging year. As Vic's commentary mentioned, "An unweighted gauge of all the companies in the S&P500 declined an average 4.68% in 2015."

At yearend 2015, equities represented approximately 72% of the portfolio (somewhat above the 65% benchmark). Fixed income and cash comprised the remaining 28%.


