# ***A gift through your estate can help you do the amazing things you want to do***

There are several popular ways to make a legacy gift to NPH USA and the Father Wasson Legacy Endowment. Each helps you plan your estate in a way that benefits you, your family, and the children of NPH.

<b>Gift Type</b>	<b>How It Works</b>	<b>Benefit To You</b>
<b>Gift in your will or trust</b>	<p>Simply add one or two sentences in your will or living trust</p> <p>You can make a gift of a specific amount, a percentage, or what remains of your estate after your commitments are taken care of</p> <p>We can help provide the specific language you'll need</p>	<p>Costs nothing during your lifetime</p> <p>Easy to include with a simple sentence or two</p> <p>Reduces estate taxes</p>
<b>Beneficiary Designation</b>	<p>Make NPH USA or the Endowment a beneficiary of your IRA, life insurance, investment accounts, or donor advised fund</p> <p>This can be done with a simple form from your provider</p>	<p>Helps avoid taxes which might be owed by your heirs</p> <p>It's simple and doesn't require a lawyer</p>
<b>Charitable Remainder Trusts</b>	<p>A charitable trust pays you or others you name an income for life or for a specific number of years... and the remainder will help support the children</p>	<p>You receive an immediate income tax deduction for a portion of the trust</p> <p>Avoids capital gains taxes</p>
<b>Real Estate</b>	<p>Real estate may be donated through a gift in your will</p> <p>In a retained life estate, you may donate your residence now and still live in it for life</p>	<p>When you give real estate owned for over a year, you can take a tax deduction for its value and avoid paying any capital gains taxes</p>

# FREQUENTLY ASKED QUESTIONS

## **Q How will my legacy gift be used?**

**A** Exactly the way you want it to be used. Your gift to NPH USA can be put to work right away caring for children in areas of critical need.

Or if you choose, your gift can be directed to The Father Wasson Legacy Endowment, where it will grow year after year along with the gifts of many others. Each year, the endowment distributes a portion of its assets to support the good work of NPH.

## **Q We're concerned about having our assets available to us for as long as we may need them.**

**A** A gift through your will or living trust may be the perfect option for you to support NPH USA's work with the children. You retain total control of all your assets during your lifetime and your spouse's lifetime. Only then is your bequest fulfilled to NPH.

The same is true for making a beneficiary designation of a life insurance policy, retirement plan, or investment account.

## **Q What if I change my mind?**

**A** The bequest or beneficiary designation you make to NPH USA or the Father Wasson Legacy Endowment is revocable. You can change your mind at any time during your lifetime.

## **Q How can we help NPH USA or the Father Wasson Legacy Endowment and also pass assets to our grandchildren?**

**A** A charitable lead trust will allow you to do exactly that. Contact us and your attorney for more details.

## **Q Can I make a legacy gift to NPH USA or the Father Wasson Legacy Endowment and receive income from that gift for my lifetime?**

**A** Yes. That's called a charitable remainder trust. We would be happy to share the details with you. Contact us.

## **Q We would love to avoid our heirs paying income taxes on our IRA. Can we donate our IRA to you?**

**A** Yes. You can designate NPH USA or the Father Wasson Legacy Endowment as a beneficiary of your IRA and avoid taxes for your heirs. It's easy and effective.
