# SAMPLE BEQUEST LANGUAGE

Making a gift in your will or living trust, known as a bequest, can help you create the legacy you wish to leave and help to care for the children of NPH today, tomorrow, and forever.

It's easy. Here's how:

If you wish to support current and immediate NPH mission needs, please direct your legacy gift to **Friends of the Orphans** (our legal name) using the following language:

"I give to **Friends of the Orphans**, Federal Tax ID# 65-1229309, a nonprofit corporation currently located at 20 N. Wacker Drive, Suite 4000, Chicago, IL 60606, or its successor thereto *[insert one of the following: a specific dollar amount, a percentage of my estate, all of the rest, residue and remainder of my estate, both real and personal, after all my other bequests and obligations have been satisfied, or a specific description of property]* for its unrestricted charitable use and purpose."

If you wish that your gift be invested and grow over time to ensure sustaining funding for future generations of vulnerable young people through the mission of NPH, consider directing your legacy gift to the **Father Wasson Legacy Endowment** using the following language:

"I give to the **Father Wasson Legacy Endowment**, Federal Tax ID# 91-2005679, a nonprofit corporation currently located at 20 N. Wacker Drive, Suite 4000, Chicago, IL 60606, or its successor thereto *[insert one of the following: a specific dollar amount, a percentage of my estate, all of the rest, residue and remainder of my estate, both real and personal, after all my other bequests and obligations have been satisfied, or a specific description of property]* for its unrestricted charitable use and purpose."

To designate your gift for a particular purpose, use the same language as above, replacing "for its unrestricted use and purpose" with:

"This gift should be used for (stated purpose) if and so long as the organization determines that the need exists. If the organization shall determine at the outset or at a later time that the need no longer exists or for some reason it is not possible (or prudent) to administer my gift as originally intended, the organization may, in its sole discretion, direct the use of my bequest for a purpose related as closely as possible to that stated above."

If you have named Friends of the Orphans or the Father Wasson Legacy Endowment in your will or trust, please let us know so we can ensure that your gift is used according to your wishes.
